

BREACH OF THE CODE OF PRACTICE FOR OFFICIAL STATISTICS

This document reports a breach of the Code of Practice for Official Statistics, or the relevant Pre-release Access to Official Statistics Orders, to which the Code applies as if it included these orders.

1. Background information

Lower level central, local and general government data associated to that published in UK economic accounts (UKEA) for the period 2015Q1 – 2016Q2 was released to PUBL status on the central shared database.

2. Circumstances of breach

Relevant Principle/Protocol and Practice

Protocol 2: release practices

Date of occurrence

29th September 2016

Nature of breach (including links with previous breaches, if any)

Data was released to an area of a centrally shared database early. The data status was set to accessible for authorised individuals outside of ONS and subsequently swept up in the morning delivery to the Bank of England before it could be retracted. Outside of ONS staff in the Bank of England were the only external individuals who could access the data.

Reasons for breach

The incorrect date on a centrally produced timetable resulted in a member of staff following desk instructions and transferring data 24 hours earlier than they should have.

3. Reactions and impact (both within the producer body and outside)

The error was identified by ONS staff shortly after the transfer had been made. Contacts in the Bank of England were alerted immediately after the error was identified and a revised dataset was provided that overwrote and replaced the incorrect data set within a few hours, thus minimising the impact. While approximately 350 Bank of England staff have access to the system, it is unlikely that any of them logged into it during the short period the incorrect data was available as staff were not expecting a delivery until the following day. The Bank of England technical support team has confirmed that they received no queries with regard to this issue from their staff

4. Corrective actions taken to prevent reoccurrence of such a breach (include short-term actions, and long-term changes made to procedures)

Area compiling central timetable - Quarterly GDP branch

Review publication timetable detail to ensure accurate tasks and information are being presented. Request business area sign off (via email/lotus notes document) to confirm full sign off.

Business area supplying data – Central Government Delivery

In the short term, additional comments have been added to desk instructions to ensure that the task is carried out only on the publication day. In the medium term we will look to transfer this activity to a central team that carries out main data transfers for Quarterly National Accounts data. This will reduce the potential for errors in data transfers.
